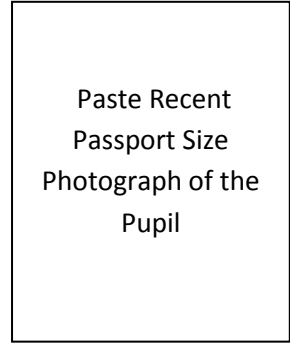

ANNEXURE-A TO APPLICATION FORM FOR ADMISSION TO LKG IN V.S.VIDYALAYA

Note:

1. Admission shall be offered according to 'order of preference'. Cat-B will be considered after offering admissions to all the applicants of Cat-A, Cat-C will be considered after offering admissions to all the applicants of Cat-A & B, .. so on.
2. In case sufficient seats are not available for any category, then 'first come first served' basis shall be followed considering the time of submission of correctly filled up application form in the office of Principal (V.S.Vidyalaya).
3. All subcategories are treated with equal priority within a category.
4. A maximum of 18 Seats are reserved for admissions into LKG. In case some of the seats of any village remains vacant; the same can be filled up from other villages too. In case there is more number of candidates for the limited seats, the same shall be decided in favour of the former candidate. The upper age limit being five years as on 31st March of the year of admission.
5. For Category-D, 5 seats are reserved [more subject to availability]. Admission in Cat-D is under the discretionary power of the Chairman, AES. The candidates considered under this shall be intimated to V.S.Vidyalaya for admission. The selected candidates in category-D shall be intimated to VSV once all other admissions have been completed. Candidates admitted in this category shall come under the non-concessional fee category.
6. For LKG Admissions, the number of seats available for Cat-A to Cat-C are 221 (Excluding 23 seats against Para 4 & 5) out of total seats 240 in SIX Sections.
