**REGISTRATION FOR NURSERY, LKG, UKG, II, IV, V, IX & STD-XI (SCIENCE) (2025-26)**

Registration of application for admission into NURSERY, LKG, UKG, II, IV, V, IX & XI(SCIENCE) classes of DAV VS VIDYALAYA for the session 2025-26 shall be open from 04.03.2025 to 29.03.2025 . Interested parents can apply online on payment of Rs.500/- (Rupees Five Hundred Only) for Nursery to Std-IX and Rs.1000/- (Rupees One Thousand Only) for Std-XI(SCIENCE). The candidate should be born between 01.09.2021 and 31.08.2022 (both days inclusive) for Nursery and 01.09.2020 to 31.08.2021 (both days inclusive) for LKG.

**25% of the seats as per RCFCE Act 2009 in the entry class are reserved for the candidates belonging to the Weaker Sections and Disadvantaged Group of the society in the neighborhood (within 1 K.M. of the school in Nursery & STD-I only)**

The last date for submission of Registration Form is 29.03.2025 till 06.00pm.

**The Disadvantaged Group and Weaker Section candidates are required to register on the Govt. portal: [www.rteparadarshi.odisha.gov.in](http://www.rteparadarshi.odisha.gov.in) for admission into entry class (NURSERY & STD-I) under sec.12(1)(c) of the RCFCE Act, 2009 as per the notification by the Govt.**

- (1) Mere registration will not confer right to admission.
- (2) Help desk for registration is available in school campus from 11.30 A.M. to 2.00 P.M. on all working days during the above period.
- (3) Aadhaar No. is essential for admission.

**1. SCHEDULE:**

**2. APPLICATION FEE**

- Rs.500/-(Rupees Five Hundred Only) for Nursery to Std-IX.
- Rs.1000/-(Rupees One Thousand Only) for Std-XI (SCIENCE).

**N.B.:-** Transaction fee charges would not be refunded/ reversed under any circumstances for any refund/ reversal /chargeback and any other reasons. Transaction fees charged would be borne by cardholder for any payment. Fees once paid which are non-refundable for any reason or any clause of DAV VS VIDYALAYA, SUNBEDA, KORAPUT.

**3. Scanned copy of documents to be required at the time of registration.**

- (a) Birth Certificate issued by the competent authority.
- (b) Aadhaar Card of the child.
- (c) Passport size (3.5 cm x 4.5 cm) photograph of the child and the parents at the space provided.
- (d) Last Class Progress Card(Not required for Nursery to Std-I)
- (e) Attested photocopy of AISSE/AISSCE certificate(s) of parents in case the ward is of an Alumnus/Alumna.

4. Under no circumstances the date and time as mentioned in admission notice for submission of above documents can be extended.

**5. Age Criteria**

- For Nursery- 01.09.2021 to 31.08.2022(Both days included)
- For LKG- 01.09.2020 to 31.08.2021(Both days included)
- For UKG- 01.09.2019 to 31.08.2020(Both days included)

**6. Registration of Disadvantages Group and Weaker Section Candidates at the Govt. portal [www.rteparadarshi.odisha.gov.in](http://www.rteparadarshi.odisha.gov.in) on free of cost from 01.03.2025 to 20.03.2025 (1<sup>st</sup> round) and from 11.04.2025 to 24.04.2025 (2<sup>nd</sup> round ) as per the notification by Govt.**

**A) In order to apply for admission in 25% reserved seats in private schools under RCFCE Act., parents and/or guardian of eligible children will visit the portal mentioned above and can apply from the Common Service Centre or Cyber cafes or by themselves or with the support of concerned school or BEO. The parent/guardian will be able to select multiple schools for admission as per his/her choice in order of priority. If the parents/guardians of the eligible children approach the Block Education Officer(BEO) with all necessary documents, then the concerned BEO will facilitate the application process through available resources in his/her office.**

**B) Documents required for Disadvantaged Group(SC/ST/SEBC-Non-Creamy Layer) & Economically Weaker Section.**

- (i) Birth Certificate issued by the competent authority.
  - (ii) Identity Proof of Parents/guardian(Aadhaar Card/Voter ID/Kisan Photo Passbook/Ration Card/PAN card/MNREGA job card/Passport/Photo attested by any Gazetted officer/Disability Certificate issued by competent authority)
  - (iii) Caste certificate issued by competent authority in case of SC/ST/SEBC.
  - (iv) Address Proof (Aadhaar Card/Ration Card/Bank statement of passbook/Voter ID Card/Driving license/Gas connection bill which is not more than 3 months old/Farmer Photo Passbook(KCC Card)/ Registered Lease/Sale/Rent Agreement/MGNREGA Job Card/Passport/Certificate in support of address given by the Sarapanch/Counsellor/Corporator/Labour Card/the certificate in support of address given by local MLA/Gazetted Officer written on their letterhead.
  - (v) Any poverty alleviation card issued by the Govt./Certificate of income issued by the competent authority in case of EWS candidates.
  - (vi) Disability Certificate/HIV positive certificate (in case of parents) issued by the competent authority in case of Children with disabilities (not less than 40%)/HIV positive of the parent(s).
  - (vii) CWC certificate issued by any CWC in case of Orphan.
- C) After submission of application through the respective online portal, parents and/or guardian of eligible students need to visit the office of the Block Education Officer(BEO), Sunabeda along with original copies of necessary documents. The BEO will validate the application and forward to the Directorate of Elementary Education through the portal.**
- D) The competent authority of the Govt. will select the candidates for each school through online Lottery considering their priority and category as per the policy and allot the candidates to the respective schools available in the vicinity of their residence.**
7. **The name of the Alumnus/Alumna who is desirous to apply for registration of his/her child should submit a separate application along with the application form.**
8. **If the applications exceed the number of seats available in any of the categories 2A(II) General and 2A(III) Alumni & staff, random selection method will be adopted and the list of selected candidates will be finalized on 04 /04/2025.**
